

# Application for authority to undertake clinical placements in NSW Public Health facilities

Students must apply to NSW Health for authority to undertake Clinical Placements within the NSW Public Health facilities, or authority to continue with Clinical Placements if they:

have offences or pending charges disclosed in their National Police Certificate, Overseas Police Certificates or Statutory Declaration; or

have been charged or convicted of offences after initially being assessed by NSW Health for employment or student placements.

Criminal history does not necessarily constitute a barrier to clinical placement. Each application is considered on its merits, and its relevance to undertaking clinical placement in NSW Public Health facilities. Mitigating factors, including but not limited to the length of time since the convictions, the nature of the convictions and action taken since by the student will be considered.

If the risks relating to the criminal history are not relevant or are considered sufficiently mitigated, NSW Health will provide a full Clearance or a Conditional Letter with authority to undertake clinical placement subject to certain conditions. If the risks relating to the criminal history are unacceptable, or the student has not provided the required documentation, NSW Health may decline the application and withdraw such authority if it had been previously provided. The student will be informed of this decision in writing and of the requirement to inform the educational institution's Clinical Placement Supervisor or Facilitator & HETI for compliance purposes.

Applications for assessment should be submitted within three months of a student's placement in NSW Public Health facilities to ensure that the most recent information is assessed. Students should allow a minimum of 15 working days for the application to be processed. Assessments are reserved for students attending placements in NSW Public Health facilities only, e.g Westmead Public Hospital not Westmead Private Hospital.

Applications for assessment should not be submitted without a scheduled placement in NS W Health.



### The following documents must be submitted:

evidence** of your next placement in NSW Public Health facilities. E.g. Westmead Public
Hospital not Westmead Private Hospital.
a completed 'Student Application for Clinical Placement Authority' form;
a certified* copy of the National Police Certificate (issued within last 5 years)
a certified* copy of an Overseas Police Certificate/s and/or Statutory Declaration
(overseas students only);
a certified* copy of your Student ID card issued by your Tertiary Education Institution;
relevant supporting documents such as work/character references, evidence that you
have successfully completed relevant training, education or treatment courses etc.

Applications must be sent in colour and sent from your email address issued by your tertiary institution or the email address you have registered with your tertiary institution if they did not issue one.

However, if you do not wish to send your application and document through email, send a request to <a href="https://health.nsw.gov.au">health.nsw.gov.au</a> for an alternative method.
